
## General information

<b>Representative product</b>	MULTIFIX ABOX 1M 12-27 mm, 6 RIG STUB+BF - IMT80274
<b>Description of the product</b>	The main purpose of Multifix Abox is to make installation work easier, to house modern devices with a larger depth.
<b>Functional unit</b>	Protect persons during 20 years against direct contact with live parts and allow grouping monitoring, control and protection devices in a single enclosure having the following dimensions 149.5 x 133.2 x 57.4, while protecting against the penetration of solid objects and liquids (IP30) in accordance with the standard IEC 60529.


