Effective July 1st, 2006, the European Directive 2002/95/EC -"Restriction of Hazardous Substances" (RoHS), its recast 2011/65/EU of June 8th, 2011, the Delegated Directive (EU) 2015/863 of March 31st 2015, restrict the use in Europe in certain electrical and/or electronic equipment's of lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE) flame retardant, and from July 22nd 2019, Bis(2-ethylhexyl) phthalate (DEHP), Butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP), Diisobutyl phthalate (DIBP).

Elko has decided to make RoHS compliance of its products one of its priorities, even if they do not fall in RoHS scope, and most of Elko products are RoHS compliant. This stance is fully in line with Elko environmental policy and EN50581 standard.
