

## Erklärung zur REACH -

überall zuhause

Dear Sir or Madam

The REACH regulation of the EU (Regulation 1907/2006 EC) demands the Registration, Evaluation and Authorisation of Chemicals).

REACH requires that all substances that are intended to be released from the product (under normal and reasonably foreseeable conditions of use) must be registered under the generally applicable regulations.

BAB TECHNOLOGIE GmbH supplies electrical engineering products that are not substances or preparations within the meaning of the regulation. As a result, there is no requirement for safety data sheets to be prepared for our products.

As a »downstream user« within the meaning of this regulation, we make sure that the substances and preparations used by us are registered - where applicable - in accordance with the REACH regulation. Our suppliers are requested to inform us of any constituents that are included in the current list of Substances of Very High Cancern (SVHC).

The REACH regulation is always available to us in the valid version with the corresponding annexes and every change is checked for relevance.

The above regulation is currently provided in the corrected version of 05.02.2009 (OJ L36/84).

Regulation (EU) No. 2020/171 (OJ L 35/1), published in the Official Journal of the European Union on 07.02.2020, amended Annex XVII of the REACH regulation.

According to Article 33 of the aforementioned regulation, we inform our customers that some of our articles contain lead (an SVHC substance) in concentrations above 0.1% in individual components. On 27.06.2018, lead (CAS 7439-92-1) was assigned to the SVHC candidate list. In addition, some of our switching contacts contain cadmium oxide in a concentration greater than 0.1%. On 20.06.2013, cadmium oxide (CAS 1306-19-0) was assigned to the SVHC list.

The use of these substances complies with the applicable legal requirements. When used as intended, there is no danger to health or the environment. Safety instructions are not required.
