DESCRIPTION OF THE PRODUCT

The RSTI Screened Separable Connector is a medium-voltage cable accessory made of modified silicone rubber with a conductive outer screen for safe earthing. It connects polymeric cables to Type "C" bushings (EN 50180/50181) up to 42 kV and 1250 A. The connector includes stress control adapters, accommodates 35–1000 mm² cables, and features a built-in capacitive test point. Suitable for indoor and outdoor use, it requires no additional sealing materials.

FUNCTIONAL UNIT

To connect together the power transmission cables, or connect them to equipment, for one unit and its packaging, under operating conditions identical to those of the cable, namely: 1 A during 30 years, with a use rate of 100%, according to the standards in force.



3 PRODUCT SPECIFICATIONS

The RSTI Screened Separable Connector is a pre-molded T-connector system for polymeric cables up to 24 kV, designed for connection to gas-insulated switchgear using type "C" bushings (EN 50180/EN 50181) rated at 630/1250 A. Made from highly modified silicone rubber with a bonded, grounded conductive screen, it ensures safe earthing and high tracking resistance. The compact design includes stress cone adapters for cable sizes from 25 to 300 mm², a capacitive test point with conductive cap, and supports double "T" connections in confined spaces. It accommodates mechanical or DIN compression lugs and allows sheath testing without disassembly. Suitable for both indoor and outdoor use, with unlimited shelf life and quick installation under all conditions.

4 MANUFACTURING PROCESS

The manufacturing process of the Screened Separable Connector RSTI involves several coordinated stages across different TE facilities. In Gevrey, France, the cable lug, made of aluminium, is cast, machined to precise dimensions, and treated for corrosion resistance before being shipped to the Szczecin plant for assembly. In Ottobrunn, Germany, the RSTI body, made from liquid silicone rubber (LSR), is moulded using injection moulding technology and quality checked before being sent to Szczecin. At the Szczecin facility, the cable lug from Gevrey is manually greased and assembled with inserts and bolts. The RSTI body is then manually assembled with the pre-assembled lug, and the complete connectors undergoes quality control. Finally, the product is packed with all required kit components, labelled, and prepared for shipment.

6 CALCULATION RULES

According to reference PCR the main activities are listed and divided in the following stages:



This declaration is a cradle to grave EPD type, based on the application of Life Cycle Assessment (LCA) methodology to the whole life-cycle system. In the whole LCA model, infrastructures and production equipment are not considered.

Customized LCA questionnaires were used to gather primary data about all aspects of the production system (for example manufacturing processes consumptions and efficiencies, waste management), to





provide a complete picture of the environmental burden of the system from raw materials supply to final products delivery.

Allocation occurs anytime a system is producing more than a single output. In this case it is necessary to choose a technique to proper split the environmental burdens among the output flows; international standards ISO 14040 and 14044 provide guidelines about how to deal with this issue, that have been implemented in this project as well. Physical allocation - based on total production amount - was adopted to consistently assign plant data (electricity for services, gas and fuel consumption, water supply, waste treatment) and electricity production process data to the product under study.

Below the sub-phases considered in the analysis are reported, per each life cycle stage:

- Kit parts transportation to Szczecin plant

- Production of packaging materials for product delivery to customers
- Process waste transportation to treatment sites from Szczecin, Gevrey and Ottobrunn plants

7 EXTRAPOLATION FACTORS

The environmental impacts for the other eight products covered by this PEP, which belong to the same product family as the reference product, can be derived from the reference product's results by applying proportionality rules based on the parameters listed in the following tables—one for each relevant life cycle stage. Since the installation phase involves only packaging waste treatment and is identical for all products, it does not vary. Similarly, the use phase does not vary, as energy consumption is negligible and consistent with the applicable Product Specific Rules (PSR) across all products. Therefore, extrapolation rules are provided only for the manufacturing, distribution, and end-of-life stages.
