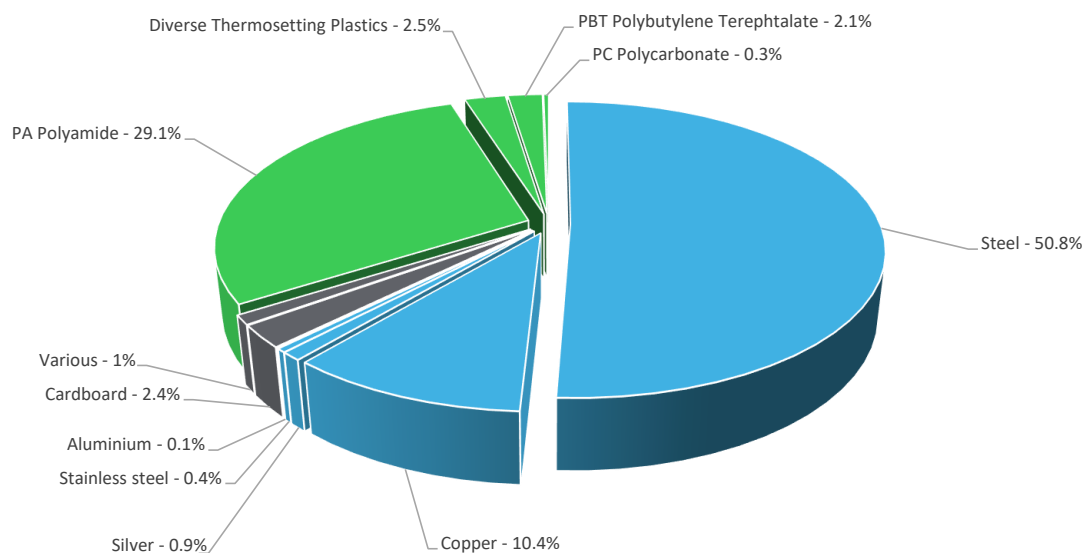
General information
