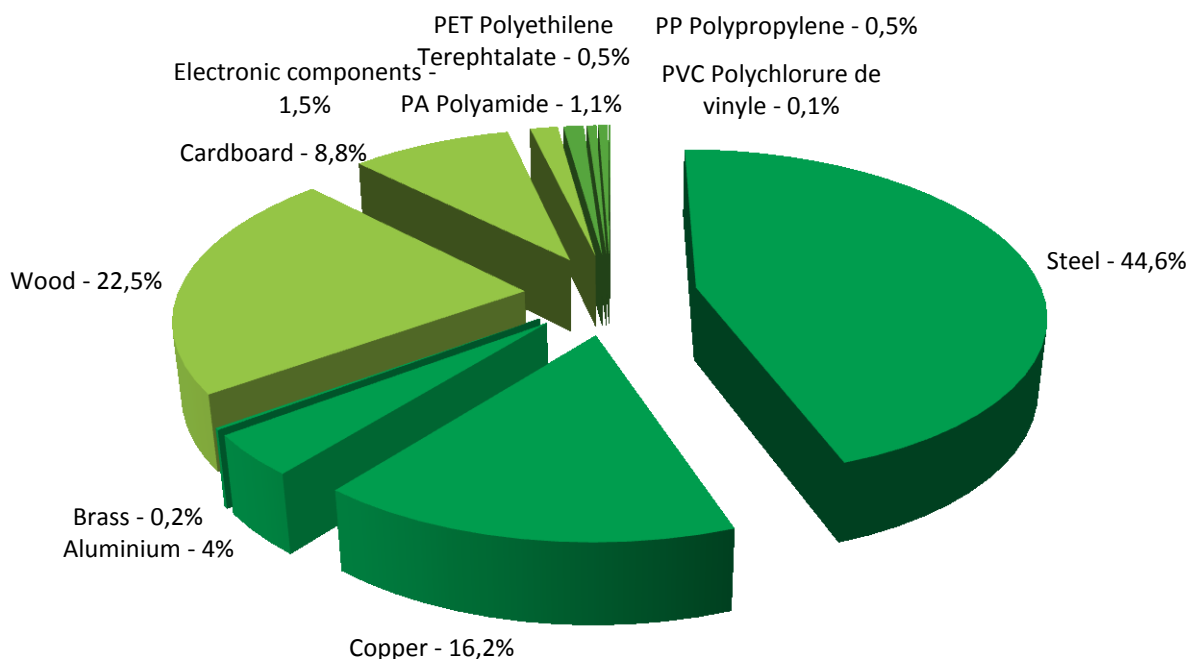

Distribution	Weight and volume of the packaging optimized, based on the European Union's packaging directive Packaging weight is 12000 g, consisting of wood (71%), cardboard (27%) and PP (2%) Product distribution optimised by setting up local distribution centers
Installation	The installation phase varies depending on the installation configuration (use of screws or not for example). As they lead to non significant impact, the installation operations have been excluded from the study scope. In addition, the installation phase includes the packaging end of life treatment.
Use	The product does not require special maintenance operations.
End of life	End of life optimized to decrease the amount of waste and allow recovery of the product components and materials This product contains electronic card (567g) that should be separated from the stream of waste so as to optimize end-of-life treatment. 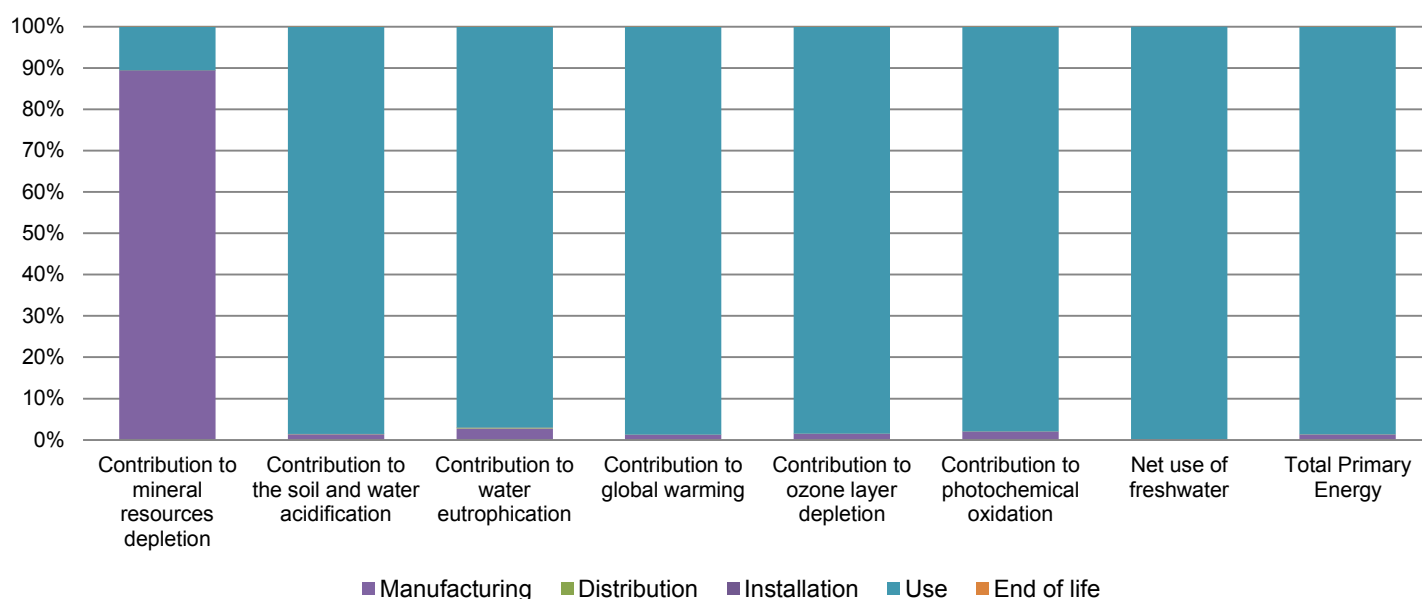
