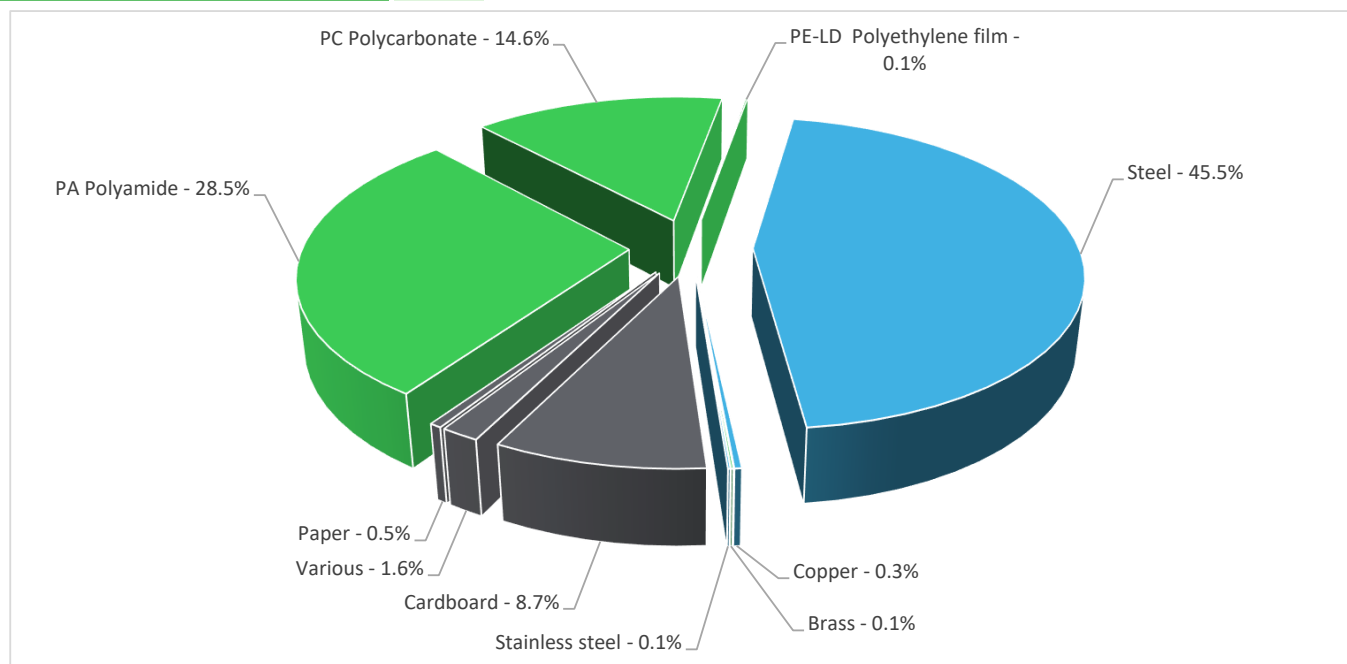

Description of the product	The main function of the Cepella Floorbox is to distribute electricity and VDI (Voice, Data, Image) to the end user in commercial buildings
Functional unit	Protect persons during 20 years against direct contact with live parts and allow grouping monitoring, control and protection devices in a single enclosure or a cabinet having the following dimensions 200 x 280 x 70, while protecting against the penetration of solid objects and liquids (IP20) in accordance with the standard IEC 60529.

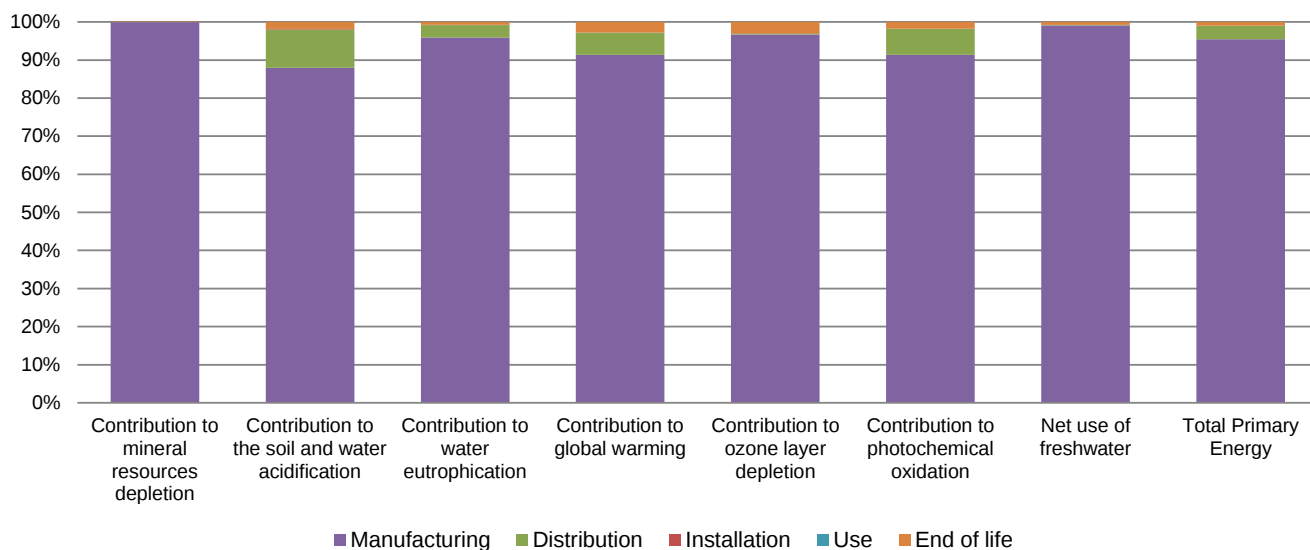
